

GENERAL INFORMATION:

The shower cabin is intended for hydrotherapeutic procedures.

The product has functions of manual shower, hydromassage and tropical shower, hydromassage sprayers, electronic control panel, FM radio, fan, lighting, chromotherapy.

TECHNICAL FEATURES:

- Installation of hydromassage cabin must be conducted by qualified specialist.
- Used voltage 220 ± 10%.
- Used water pressure 0.2-0.4 MPa, water discharge 8-12 l/min. Temperature of hot water fed onto the cabin should not exceed 70°C. Installation of coarse water filters is required.
 - · Level of canalization draining from floor up to tray must be at least 70 mm.
 - · Maximum load to the tray 150 kg.
- Mounting dimensions of hot and cold water pipeline 1/2" (15 mm), drainhole diameter 1-1/2" (40 mm).
 - Upon finishing to use the cabin it is necessary to put a switch to OFF position.

Upon finishing to use the cabin it is necessary to shut down feeding of cold and hot water in the cabin.



LIST OF PROHIBITED ACTIONS!

- · Installing the cabin on the street
- · Misusing the cabin
- Using the cabin in the state of alcohol and intoxicated
- · Standing on the edge of the tray
- · Using the cabin by the people who have fear of closed space
- Using the cabin by children and elderly people without supervision by relatives
- Clean the sower cabin using abrasive and agressive detergents.

TRANSPORTATION AND STORAGE:

The cabins are transported in a covered vehicle.

If the cabin subject to installation is delivered from the cold premise to the warm one, it is necessary for each part of it to match the environment temperature first. After purchase the product has to be stored in the package in order to be accepted for after-sales service, before installation and acceptance for warranty service.

RECOMMENDATIONS TO THE CUSTOMER:

- This product is intended for domestic use in the premises.
- Packaging elements (plastic bags, metal clips) may be potentially dangerous for children, thus put them away to the unreachable place immediately after installing the cabin.
- It is necessary to check completeness and integrity of the product after opening the package.
- Always take the plug out of the socket or turn the electricity off on your electric service panel before starting any cabin maintenance operations.
- Water feeding regulator must be in the middle position in order to avoid temperature shock If you are using a sauna mode, don't use the shower or hydromassage.
- Cleaning of shower cabin must be conducted with a soft cloth or a sponge using liquid detergents.
 - · Water feeding system must be equipped with filters.
 - It is not recommended to wash pets without using a protection rug.



When you're ready to start, make sure that you have the parts listed and the following tools to hand, plenty of space and a clean dry area for assembly.


Two people are needed. Please note: although these

instructions are comprehensive, we always recommend that a technically competent installer should undertake installation.











Installation Of Iron Shelf.(Adjust The Height,check The Balance Of Tray)




Install The Accessories On The Panel, And Fixed It With Back Glass By Screws.










Bracket Installation












Installation Of Front Fixed Glass.

























TOP INSTALLATION







- when installing, the ground wire on shower booth should be reliably connected.
- It is prohibited to connect zero line of three-hole socket with ground wire.
- Under spcial person nurse, old peple, chid and disable peple use the shower booth.

Cleaning and maitenance

1.Clean the integrated shower booth with ordinary cleanser and soft cloth,don't use

cleanser with acetone or ammonia solution.

- 2.If its surface has nick, you may polish it with soft cloth.
- 3.Don't often wipe gold-plated and aluminium-plate fittings.
- 4.Don't use rough tool. chemical solvent or granule cleanser to clean its surface.
- 5.Don't use blunt tool and cutting tool to knock or score its surface.

Notice on transport and storage

- 1.During storing, it is prohibited to place it upside down and pile it up, and it is far away from organic solvent such as formic acid and formaldehyde.
- 2.During, carrying, must gently take and set it, and it is prohibited to heavily press, knock and vehemently shake.
- 3.If don't use it for a long time, should put it in a dry and ventilated place and is far away from corrosive gas.

Warranty Policy for DETO Shower Cabins of the «Cities of the World» Collection.

Thank you for choosing DETO products!

All enquiries regarding installation, exploitation and maintenance of DETO shower cabins should be addressed to service centers.

The present warranty policy supplements rights and obligations of consumers defined by law and restricts them by no means.

The service life of DETOshower cabin is 10 years, within this period the manufacturer shall provide the customer with the possibility to obtain spare parts.

The extended manufacturer's warranty for DETO shower cabins of the «Cities of the World» collection is 5 years after sales date and 7 years after sales date if installed by authorized service center employees (except for equipment installed in public accommodations). The manufacturer's warranty for the components, such as rollers, mixer cartridges and electrical elements is 1 year after sales date.

When contacting a trading organization or service center the customer needs to have proofs of the fact that the agreement was signed and the goods were paid for.

Product appearance and completeness must be checked by the customer at the moment of receiving the dismantled product; further claims regarding appearance and completeness will not be accepted.

The warranty shall not apply to product shortcomings occurred as a result of circumstances the manufacturer is not responsible for, including:

- products, marketable appearance of which was damaged during product transportation
 after the moment it was handed over to a customer, installation or product repair performed
 by unauthorized parties, as well as violation of cabin exploitation rules.
- malfunctions, which were caused by reasons the manufacturer is not responsible for, such as
 pressure differentials in water-pipe and electric networks, corrosion of pipes and quality of tap
 water. In order to avoid such events the manufacturer strongly recommends installing pressure
 reducer, mechanical cleaning filter and protective cutout device (PCD) when installing the
 cabin.
- damages caused by natural disasters.
- cases of damages caused by using maintenance products containing aggressive chemicals
 or abrasive agents not intended to be used with this product.

In order to receive a warranty service a customer must ensure free access to the cabin.
